The District Court noted that even if the court were to construe the family provision as a designation of legal parentage, it would be required to take judicial notice of the fact that the child was born after the child's father's death, and did not become a legal parent until after his father's death. We agree, and discern no error in the District Court's conclusion. 3 "We are required to give full effect to a trust provision, if one exists, if consistent with and not in contravention of the laws of the state under which a trust is created." Haehl v. One Thousand Four Hundred Ten Dollars (\$1,410.00) in the Joud Report Money, 740 P.2d 548, 552 (Alaska App. 1987). Therefore, we must consider the trust agreement in the instant case and determine whether its unambiguous language manifests clear intent on the part of the settlor to create a trust for his children. 4 The District Court also noted that even if it were to accept the argument that the trust created a trust for the children, the family provision would preclude any claims for past-due child support. The provision stated that "[i]f a child dies or is otherwise adjudged emancipated, the Trustee shall distribute the remaining Trust Property to his or her spouse and children in equal shares." Because Andrew, the deceased son, was a child at the time of his father's death, the trust did not have any remaining property to distribute to his children. Thus, his children would be precluded from recovering any past-due child support in the District Court.
